Dear shareholder

Share Purchase Plan – Eligible Shareholders may purchase parcels of fully paid ordinary shares up to a value of A\$15,000

On behalf of Variscan Mines Limited ("Variscan" or "the Company"), I am pleased to offer you the opportunity to increase your shareholding in Variscan through a Share Purchase Plan (the SPP).

As announced on 25 November 2015, Variscan recently secured a placement of fully paid ordinary shares at 2.3 cents per share to raise \$1,350,000 (**Equity Placement**). The Equity Placement was underpinned by a cornerstone investment of \$750,000 by institutional investor Acorn Capital Limited

The purpose of the Placement and SPP is to raise funds to enable the completion of a JORC Compliant Resource for its high grade Porte-aux-Moines zinc deposit (located within the Merleac licence), progress the Company's exploration activities within its key tenements in France and provide working capital.

The SPP provides shareholders with the opportunity to take up Variscan shares at an issue price of 2.31 cents per share based on the issue price of the shares in the Equity Placement expanded to two decimal points to comply with the maximum discount allowable for an SPP under ASX listing Rules. Details of the Company's Porte-aux-Moines project are provided in the Company's ASX announcements of 20 and 29 July 2015, 28 September 2015, in the Company's September 2015 Quarterly Activities Report and in a recent Company presentation released on 25 November 2015. #### The Share Purchase Plan

The amount that each Eligible Shareholder can apply for under the SPP is capped at A\$15,000.

As mentioned above the SPP is being offered to Australian and New Zealand Shareholders at A\$0.0231 per new fully paid ordinary share (*New Shares*).

The Issue Price represents a 19.85% discount to the volume weighted average price ("VWAP") of the Company's Shares on the Australian Securities Exchange ("ASX") during the 5 trading days immediately prior to the announcement date of the Offer (being 25 November 2015).

#### The offer

The SPP is offered exclusively to all Eligible Shareholders, being registered holders as at 7pm (Sydney time) on Tuesday, 24 November 2015 (*Record Date*) with a registered address in Australia or New Zealand who meet certain other conditions as set out in the Terms and Conditions.

The SPP provides Eligible Shareholders with an opportunity to buy a parcel of New Shares in Variscan valued at A\$2,500, A\$5,000, A\$7,500, A\$10,000, A\$12,500 or A\$15,000.

The SPP opens today and is expected to close at 5pm (Sydney time) on Wednesday, 23 December 2015.

Participation in the SPP is entirely voluntary. All New Shares issued under the SPP will rank equally with existing fully paid ordinary shares and will carry the same voting rights and entitlement to receive distributions. No brokerage costs apply to purchases under the SPP. The issue of New Shares is expected to occur on Wednesday, 30 December 2015

To apply for New Shares under the SPP, please follow the instructions in the accompanying Terms and Conditions and in the enclosed personalised Application Form.

If you are in any doubt about whether or not, or the extent that, you should participate in this SPP, you should obtain professional financial and/or taxation advice to assist you (taking into account your own financial situation, needs and objectives). Nothing in these Terms and Conditions, the Application Form or any other accompanying documentation constitutes investment or financial product advice or is intended to influence your decision whether or not to participate in the SPP.

If you apply to participate in the SPP by making a BPAY® payment or completing and returning the Application Form with a cheque or money order, you are accepting the risk that the market price of shares in Variscan may change between the Opening Date, the date on which you send in an Application Form or make a BPAY® payment and the Allotment Date. This means it is possible that, up to or after the Allotment Date, you may be able to buy shares in Variscan at a lower price than the Issue Price.

Set out below are the terms and conditions of the Variscan Mines Limited Share Purchase Plan which are binding on any Shareholder completing a Share Purchase Plan Application Form or applying via BPAY. The Application Form forms part of this document.

Capitalised terms used in these Terms and Conditions are both defined in the body of these Terms and Conditions as well as in clause 16.

#### 1. The SPP

- (a) The SPP is an invitation to Eligible Shareholders by Variscan Mines Limited (*Variscan*) to subscribe for fully paid ordinary shares in Variscan (*Variscan Shares*) at the Issue Price (see clause 5 below) per New Share.
- (b) The minimum application amount under the SPP is A\$2,500. All applications must be in increments of A\$2,500.
- (c) The amount an Eligible Shareholder can apply for will be restricted to a cumulative total of A\$15,000.
- (d) The SPP is conducted in accordance with the Corporations Act, ASIC Class Order CO 09/425 and the ASX Listing Rules.
- (e) You are not obliged to accept or otherwise participate in the SPP. **Participation in the SPP is optional**.
- (f) The SPP is made to each Eligible Shareholder on the same terms and conditions.
- (g) The offer under the SPP is non-renounceable, which means you may not transfer your right to apply for New Shares under the SPP to anyone else.

# 2. Opening and Closing Date of the SPP

The SPP opens on 2 December 2015 and is scheduled to close at 5.00pm (Sydney time) on 23 December 2015. Variscan reserves the right to change the closing date of the SPP. No late applications will be accepted.

## 3. Eligible Shareholders

- (a) You are eligible to participate in the SPP (*Eligible Shareholder*) if you were a registered holder of fully paid ordinary shares in Variscan at 7.00pm (Sydney time) on 24 November 2015 (*Record Date*) whose address in the security register of Variscan is in Australia or New Zealand. unless:
  - you hold Variscan Shares on behalf of another person who resides outside Australia or New Zealand and do not hold Variscan Shares in any other capacity;
  - (ii) you are in the United States or you are a U.S. Person, or acting for the account or benefit of a U.S. Person; or
  - (iii) you are ineligible to participate in the SPP because of the aggregate limit explained in clause 4 below.
- (b) (**Single Holders**) If you are the only registered holder of Variscan Shares, but you receive more than one offer under the SPP (for example, due to multiple registered holdings), you may only apply for one maximum parcel of New Shares up to the value of A\$15,000.
- (c) (Joint Holders) If you are recorded with one or more other persons as the joint holder of Shares, that joint holding is considered to be a single registered holding for the purposes of the SPP and, subject to the conditions of eligibility set out in this clause (a), the joint holders are entitled to participate in the SPP in respect of that single holding only. The certification under clause (a) by one joint holder will be effective in respect of the other joint holder(s). - (b) The current Variscan Share price can be obtained from the ASX website at www.asx.com.au (ASX code: VAR) and is listed in the financial and business section of major daily newspapers circulated in Australia.
- (c) The Issue Price represents a 19.85% discount to the volume weighted average price ("VWAP") of the Company's Shares on the Australian Securities Exchange ("ASX") during the 5 trading days immediately prior to the announcement date of the Offer (being 25 November 2015). The Issue Price also represents a 20.47% discount to the VWAP of the Shares on the ASX during the 10 trading days prior to the announcement date of the Offer.
- (d) You agree to pay the Issue Price for each New Share.
- (e) You acknowledge that the market price of New Shares may rise or fall between the date of this SPP and the date that New Shares are allotted to you under the SPP (*Allotment Date*) and that the effect of this is that the Issue Price you pay for the New Shares may exceed the market price of Variscan Shares on the Allotment Date.

## 6. Applying for New Shares

(a) Eligible Shareholders may apply to purchase a parcel of New Shares above a minimum of A\$2,500 and only in increments of A\$2,500, up to a maximum of A\$15,000. If you are an Eligible Shareholder and wish to participate in the SPP, you must follow the instructions on the SPP Application Form (*Application Form*) and:

- (i) make payment by BPAY® equivalent to the value of the parcel of New Shares you wish to apply for, using the information provided on the application form; **or**

- (b) If you apply for New Shares under the SPP, you will apply for a certain value, rather than a certain number, of New Shares. Subject to clause (c), Variscan will divide the parcel value you select by the Issue Price in order to determine the number of New Shares for which you have applied (rounded down to the nearest whole number of New Shares). Any balance of monies sent by you that is remaining as a result of rounding will be refunded to you except where the amount is less than A\$2.00 (or an amount advised by Variscan).

Importantly, there is a risk that during the period between when you apply for New Shares and when the New Shares are issued to you, the price at which Variscan Shares are traded on the ASX may be less than the Issue Price payable under this SPP.

(Allotment Date) Variscan proposes to allot the New Shares on 30 December 2015;

(**Despatch Date**) the date on which transaction confirmations are sent to securityholders and, if applicable, a direct credit deposit to your nominated account is made or refund cheque is dispatched, is expected to be 4 January 2016; and

(Trading Date) the New Shares are expected to commence trading on 6 January 2016.

## 10. Waiver, Amendment, Suspension and Withdrawal

Variscan may, at its discretion, waive compliance with any provision of these Terms and Conditions, amend or vary these Terms and Conditions or suspend or withdraw the offer made under this SPP at any time and in its absolute discretion. Any such waiver, amendment, variation, suspension or withdrawal will be binding on all Eligible Shareholders even where Variscan does not give notice of the event. However, the rights of any Eligible Shareholder in connection with any New Shares that have been duly issued and allotted to that person prior to the occurrence of any such waiver, amendment, variation, suspension or withdrawal will not be affected as a result of any such occurrence.

Variscan is not liable for any loss, cost, expense, liability or damage arising out of exercise of any of its discretions under these Terms and Conditions.

## 11. Rights Attaching

The rights and obligations of the New Shares are contained in the Variscan Constitution. The New Shares will be issued on the same terms as all other Variscan Shares and Variscan will

apply for the New Shares proposed to be issued under the SPP to be quoted on the ASX. If the New Shares are not quoted on the ASX, the New Shares will not be issued and all application monies will be refunded.

#### 12. Costs of Participation

No brokerage costs will be payable by Eligible Shareholders in respect of the application for, and allotment of, New Shares under the SPP.

# 13. Privacy

By receiving completed Application Forms, Variscan collects personal information about Shareholders. Variscan will use this information for the purposes of processing the Application Form and updating the records of Variscan. To the extent restricted by law, Variscan will not disclose personal information about a Shareholder to a third party. To the extent permitted by law, Shareholders are able to access, upon request, personal information about them held by Variscan.

## 14. Dispute Resolution

Variscan may settle in any manner it thinks fit, any difficulties, anomalies or disputes that may arise in connection with or by reason of the operation of the SPP. The decision of Variscan will be conclusive and binding on all participants and other persons to whom the determination relates. Variscan's rights may be exercised by the Board or any delegate of the Board.

## 15. Governing Law

These Terms and Conditions are governed by the laws in force in New South Wales. Any dispute arising out of or in connection with these Terms and Conditions, or the offer of New Shares, will be determined by the courts of New South Wales. By accepting this offer, you agree to submit to the exclusive jurisdiction of the courts in New South Wales.
