## **Thomson Project Exploration Funding**

Minotaur Exploration (**ASX: MEP**) is pleased to announce that it and joint venture partner PlatSearch NL (**ASX: PTS**) have decided to progress exploration in the Thomson Fold Belt Project by way of a new investment vehicle, Thomson Resources Ltd.

Since early 2007 the two companies have formed seven joint ventures to explore 10 exploration licences covering 2,229 square kilometres in north western New South Wales. To date, nine rotary/core holes have tested eight prospects, targeting discrete magnetic anomalies. Three holes (at F16, F3 and F17 prospects) intersected iron sulphides in the form of disseminated and vein pyrrhotite, and intervals of elevated geochemistry including high silver (up to 70.5 g/t Ag) and tungsten (389ppm), signifying that a metalliferous, hydrothermal system has been operative in the area.

Minotaur and PlatSearch remain encouraged by the results obtained so far and are evaluating additional funding mechanisms to help fast track exploration into this region. It is proposed that a new public company, Thomson Resources Ltd (TMO), will be incorporated to be the prime mover in this region and that both Minotaur and PlatSearch will seek to have Board representation and a significant shareholding in TMO.

The Thomson Fold Belt is the interpreted covered northern extension of the Siluro-Devonian Cobar Basin, a major metallogenic province which hosts a number of large, high-grade base and precious metal deposits such as the world-class Endeavor deposit (+50Mt at >12% Zn+Pb, Ag). Minotaur and PlatSearch now hold a dominant ground position within a belt that can be expected to generate new mineral discoveries provided sufficient, long term, well targeted exploration funding is focused into the region.






Figure 1: Thomson project location
