Under an agreement with Silver City Minerals Limited, Broken Hill Operations and Eaglehawk Geological Consulting Pty Ltd, PlatSearch has converted its interest in parts of these tenements to a NSR (Net Smelter Return).
- Note 2: Eastern Iron Limited (EFE) is currently owned 45.8% by PlatSearch and PlatSearch holds options in EFE. EFE holds (100%) EL 4509 and EPCs 2175 and 2206. EFE is also earning an interest in EPMs 15289 and 17099.
- Note 3: EL 4289 held 47.4% by Dolores Group (Allender, Kennedy, Aurelius Resources, Hosking and Houldsworth).
- Note 4: Marmota has earned 100% of the uranium rights only in EL 4509. PlatSearch has retained a 3.75% net profits royalty on production from a uranium mine.
